1 Short title

This Act may be cited as the *Carbon Credits (Carbon Farming Initiative) Act 2011*.

2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

Climate Change Convention and Kyoto Protocol etc.

- (2) The first object of this Act is to remove greenhouse gases from the atmosphere, and avoid emissions of greenhouse gases, in order to meet Australia's obligations under any or all of the following:
 - (a) the Climate Change Convention;
 - (b) the Kyoto Protocol;
 - (c) an international agreement (if any) that is the successor (whether immediate or otherwise) to the Kyoto Protocol.

Incentives

(3) The second object of this Act is to create incentives for people to carry on certain offsets projects.

Carbon abatement

- (4) The third object of this Act is to increase carbon abatement in a manner that:
 - (a) is consistent with the protection of Australia's natural environment; and
 - (b) improves resilience to the effects of climate change.

Purchase of carbon abatement by the Commonwealth

(5) The fourth object of this Act is to authorise the purchase by the Commonwealth of units that represent carbon abatement.

4 Simplified outline

The following is a simplified outline of this Act:

- This Act sets up a scheme for the issue of Australian carbon credit units in relation to eligible offsets projects.
- Australian carbon credit units and certain other types of units may be purchased by the Commonwealth.

- This Act is administered by the Clean Energy Regulator.

- The Regulator must have regard to certain principles and other matters when conducting a carbon abatement purchasing process.

Division 2—Carbon abatement contracts

20B Carbon abatement contracts

- (1) The functions of the Regulator include entering into contracts, on behalf of the Commonwealth, for the purchase by the Commonwealth of eligible carbon credit units.
- (2) It is immaterial whether the units are in existence when the contract is entered into.
- (3) For the purposes of this Act, a contract entered into under subsection (1) is to be known as a *carbon abatement contract*.
- (4) For the purposes of this Act, if the Regulator enters into a carbon abatement contract with a person, the person is a *carbon abatement contractor*.

20C When carbon abatement contracts may be entered into

- (1) The Regulator may enter into a carbon abatement contract under section 20B as the result of a carbon abatement purchasing process conducted by the Regulator under section 20G.
- (2) The Regulator must not enter into a carbon abatement contract under section 20B unless the carbon abatement contractor for the contract is a project proponent for an eligible offsets project.

 - (b) an amount payable to the Commonwealth under a carbon abatement contract is to be paid to the Regulator on behalf of the Commonwealth; and
 - (c) the Regulator may institute an action or proceeding on behalf of the Commonwealth in relation to a matter that concerns a carbon abatement contract.

20E Conferral of powers on the Regulator

The Regulator may exercise a power conferred on the Regulator by a carbon abatement contract.

20F Carbon abatement purchasing process

- (f) provide for fair and ethical treatment of all participants in the process.
- (4) To avoid doubt, the mere fact that a person is a project proponent for an eligible offsets project does not automatically entitle the person to participate in a carbon abatement purchasing process.

Division 4—Miscellaneous

20H Legislative rules may provide for certain matters relating to purchased eligible carbon credit units etc.

- (1) The legislative rules may make provision for and in relation to any or all of the following matters in respect of eligible carbon credit units purchased by the Commonwealth under carbon abatement contracts:
 - (a) transferring purchased units to a specified Commonwealth Registry account;
 - (b) prohibiting or restricting the transfer of units from such an account;
 - (c) cancelling units for which there are entries in such an account.

Note: For designation of Commonwealth Registry accounts, see section 12 of the Australian National Registry of Emissions Units Act 2011.

Restoration of units that were transferred by mistake

- (2) If:

 - (c) the Regulator is satisfied that the units were transferred by mistake;

- (d) the Regulator must, by written notice given to the person, determine that the units that were transferred are *restored units* for the purposes of this section; and
- (e) a restored unit is taken never to have been cancelled; and
- (f) the Regulator must make an entry for a restored unit in a Registry account kept by the person.

 - (i) the project is an area-based offsets project; and
 - (ii) the project area, or any of the project areas, for the project is covered by a regional natural resource management plan;

the Regulator must not issue the units.

- (4) Regulations or legislative rules made for the purposes of subsection (2) may empower the Regulator to determine that, whenever it is necessary to calculate a unit entitlement in relation to the transferee offsets project using the formula in subsection 16(2), that subsection has effect, in relation to the transferee offsets project, as if the net abatement number were increased by the number specified in the determination.
- (5) Regulations or legislative rules made for the purposes of subsection (2) may empower the Regulator to determine that, whenever it is necessary to work out the net total number of Australian carbon credit units issued in relation to the transferor offsets project, this Act has effect, in relation to the transferor offsets project, as if the net total number of Australian carbon credit units issued in relation to the project in accordance with Part 2 were decreased by the number specified in the determination.
- (6) Regulations or legislative rules made for the purposes of subsection (2) may empower the Regulator to determine that, whenever it is necessary to work out the net total number of Australian carbon credit units issued in relation to the transferee offsets project, this Act has effect, in relation to the transferee offsets project, as if the net total number of Australian carbon

credit units issued in relation to the project in accordance with Part 2 were increased by the number specified in the determination.

(7) Subsections (3) to (6) do not limit subsection (2).

Determination is not a legislative instrument

59 Simplified outline of this Part

- A person passes the fit and proper person test if:
 - (a) the person is a fit and proper person; and

 - (ii) whether any of the events specified in the legislative rules have happened in relation to an executive officer of the body corporate; and

 - (ii) prepared by a registered greenhouse and energy auditor who has been appointed as an audit team leader for the purpose; and
- (cc) if a notice under section 77A is relevant to the offsets report—be accompanied by a copy of that notice; and
- (d) be accompanied by such other documents (if any) as are specified in the regulations or the legislative rules; and
- (e) be given to the Regulator within:
 - (i) 6 months after the end of the reporting period; or
 - (ii) if a greater number of months is specified in the applicable methodology determination for the project that greater number of months after the end of the reporting period.
- (5) The Regulator must not give a notice under paragraph (4)(cb) unless the Regulator is satisfied that it is appropriate to do so, having regard to effective risk management.

- (a) if the project is a 100-year permanence period project—the 100-year permanence period for the project; or
- (b) if the project is a 25-year permanence period project—25 years.

 - (iii) the person did not comply with the requirement within 90 days after the notice was given;
 - when the penalty payable under section 179 in respect of the non-compliance with the requirement (including any late payment penalty payable under section 180 in relation to the section 179 penalty) is paid in full;
- (c) if the relevant section 27 declaration has never been varied so as to add one or more project areas—the end of the period that:
 - (i) begins on the first occasion on which an Australian carbon credit unit was issued in relation to the project in accordance with Part 2; and
 - (ii) is of the same duration as the permanence period for the project;
- (d) if the relevant section 27 declaration has been varied so as to add one or more project areas—the end of the period that:
 - (i) begins on the last occasion on which the declaration was so varied; and
 - (ii) is of the same duration as the permanence period for the project.

Declaration is not a legislative instrument

(15) A declaration made under subsection (2) is not a legislative instrument.

 - (c) a person specified in the regulations or the legislative rules; and
 - (d) the relevant land registration official.

99 Revocation of declaration of carbon maintenance obligation—voluntary relinquishment of Australian carbon credit units

 - (b) in the case of a single area—the area is not, and is not part of, a project area for an eligible offsets project that is a sequestration offsets project; and

 - (a) the project proponent for the project; and
 - (b) each person who holds an eligible interest in the area, or any of the areas, of land; and
 - (c) a person specified in the regulations or the legislative rules; and
 - (d) the relevant land registration official.
- (5) A failure to comply with subsection (4) does not affect the validity of a variation or revocation.

Refusal

(6) If the Regulator decides to refuse to revoke the declaration, the Regulator must give written notice of the decision to the applicant.

Revocation is not a legislative instrument

(7) A revocation of the declaration is not a legislative instrument.

Division 3—Injunctions

100 Injunctions

Performance injunctions

- (1) If:
 - (a) a person has refused or failed, or is refusing or failing, or is proposing to refuse or fail, to do an act or thing; and

Restraining injunctions

 - (a) restraining the person from engaging in the conduct; and
 - (b) if, in the Court's opinion, it is desirable to do so—requiring the person to do something.

101 Interim injunctions

Grant of interim injunction

(1) If an application is made to the Federal Court for an injunction under section 100, the Court may, before considering the application, grant an interim injunction restraining a person from engaging in conduct of a kind referred to in that section.

(2) The Federal Court is not to require the Regulator, as a condition of granting an interim injunction, to give any undertakings as to damages.

102 Discharge etc. of injunctions

Performance injunctions

- (1) The power of the Federal Court to grant an injunction requiring a person to do an act or thing may be exercised:

 - (b) if it appears to the Court that, if an injunction is not granted, it is likely that the person will refuse or fail to do that act or thing—whether or not the person has previously refused or failed to do that act or thing.

Restraining injunctions

- (2) The power of the Federal Court under this Division to grant an injunction restraining a person from engaging in conduct of a particular kind may be exercised:
 - (a) if the Court is satisfied that the person has engaged in conduct of that kind—whether or not it appears to the Court that the person intends to engage again, or to continue to engage, in conduct of that kind; or
 - (b) if it appears to the Court that, if an injunction is not granted, it is likely that the person will engage in conduct of that

kind—whether or not the person has previously engaged in conduct of that kind.

Division 1—Introduction

105 Simplified outline

The following is a simplified outline of this Part:

- The Minister may make or vary a methodology determination that applies to a specified kind of offsets project.
 - Before making or varying a methodology determination, the Minister must request the Emissions Reduction Assurance Committee to advise on the proposed determination or variation.
- In making or varying a methodology determination, the Minister must have regard to:
 - (a) advice given by the Emissions Reduction Assurance Committee; and
 - (b) the offsets integrity standards; and
 - (c) certain other matters.

Division 2—Methodology determinations

Subdivision A—Making of methodology determinations

106 Methodology determinations

- (1) The Minister may, by legislative instrument, make a determination that:
 - (a) is expressed to apply to a specified kind of offsets project; and
 - (b) sets out requirements that must be met for such a project to be an eligible offsets project; and
 - (c) provides that, if such a project is an eligible offsets project, the carbon dioxide equivalent net abatement amount for the project in relation to a reporting period for the project is taken, for the purposes of this Act, to be equal to the amount ascertained using a method specified in, or ascertained in accordance with, the determination.
 - Note 1: For declarations of eligible offsets projects, see section 27.
 - Note 2: See also subsection 27(4A) in relation to certain additionality requirements that may be specified in a methodology determination.
 - Note 3: See also sections 69, 70 and 71 in relation to specifying a crediting period in a methodology determination.
 - Note 4: See also paragraph 76(4)(e) in relation to specifying in a methodology determination the deadline for giving an offsets report.
 - Note 5: See also subsection 77A(2) in relation to setting out in a methodology determination requirements relating to the division of an offsets project into 2 or more parts.
- (2) A determination under subsection (1) is to be known as a *methodology determination*.
- (3) A methodology determination that applies to a particular kind of offsets project may provide that, if such a project is an eligible offsets project, the project proponent for the project is subject to any or all of the following requirements:

- (a) specified requirements to include specified information relating to the project in each offsets report about the project;
- (b) specified requirements to notify one or more matters relating to the project to the Regulator;
- (c) specified record-keeping requirements relating to the project;

- (4) In deciding whether to make a methodology determination, the Minister must have regard to the following:
 - (a) whether the determination complies with the offsets integrity standards:
 - (b) any advice that the Emissions Reduction Assurance Committee has given to the Minister under subsection 123A(2) in relation to the making of the determination;
 - (c) whether any adverse environmental, economic or social impacts are likely to arise from the carrying out of the kind of project to which the determination applies;
 - (d) such other matters (if any) as the Minister considers relevant.
- (4A) The Minister must not make a methodology determination unless a method specified in, or ascertained in accordance with, the determination in accordance with paragraph (1)(c) provides that carbon abatement used in ascertaining the carbon dioxide equivalent net abatement amount for a project is eligible carbon abatement from the project.
- (4B) The Minister must not make a methodology determination if the Emissions Reduction Assurance Committee has advised the Minister under subsection 123A(2) that the determination does not comply with one or more of the offsets integrity standards.
 - (7) Paragraph (1)(a) of this section does not, by implication, affect the application of subsection 13(3) of the *Legislation Act 2003* to another instrument under this Act.

- (10) Before making a methodology determination, the Minister must request the Emissions Reduction Assurance Committee to advise the Minister about whether the Minister should make the determination.

Note: The Emissions Reduction Assurance Committee must have regard to certain matters in giving advice to the Minister (see section 123A).

- (11) If the Minister decides:
 - (a) to make a methodology determination; or
 - (b) not to make a methodology determination;

the Minister must:

- (c) cause a copy of any advice given by the Emissions Reduction Assurance Committee under subsection 123A(2) in relation to the determination to be published on the Department's website; and
- (d) do so as soon as practicable after making the decision.

Subdivision B—Variation of methodology determinations

114 Variation of methodology determinations

(1) The Minister may, by legislative instrument, vary a methodology determination.

 - (7) In deciding whether to vary a methodology determination, the Minister must have regard to the following:
 - (a) any relevant advice given by the Emissions Reduction Assurance Committee under subsection 123A(2);

- (7A) The Minister must not vary a methodology determination so as to extend the crediting periods for the eligible offsets projects covered by the determination unless:
 - (a) the Emissions Reduction Assurance Committee has advised the Minister under subsection 123A(2) or paragraph 255(hc) that the variation should be made; and
 - (b) the Emissions Reduction Assurance Committee has not previously advised the Minister under subsection 123A(2) or paragraph 255(hc) that the variation should not be made; and
 - (c) the determination has not previously been varied so as to extend the crediting periods.
- (7B) The Minister must not vary a methodology determination if the Emissions Reduction Assurance Committee has advised the Minister under subsection 123A(2) that the varied determination does not comply with one or more of the offsets integrity standards.
 - (8) If the Minister decides:
 - (a) to vary a methodology determination; or
 - (b) not to vary a methodology determination;

Subdivision C—Duration of methodology determinations

122 Duration of methodology determinations

- (1) A methodology determination:
 - (a) comes into force:
 - (i) when it is made; or
 - (ii) if a later time is specified in the determination—at that later time; and
 - (b) unless sooner revoked, remains in force for:
 - (i) the period specified in the determination; or
 - (ii) if a longer period is specified in relation to the determination in a legislative instrument made by the Minister—that longer period.
- (2) Paragraph (1)(a) has effect subject to section 130.

Note: Section 130 deals with approval of the application of a specified methodology determination to a project with effect from the start of a reporting period.

(4) If a methodology determination expires, this Act does not prevent the Minister from making a fresh methodology determination in the same terms as the expired determination.

Subdivision DA—Advice about making, varying or revoking methodology determinations

123A Advice by the Emissions Reduction Assurance Committee

 - (a) under subsection 106(10), to give advice about whether the Minister should make a methodology determination; or

Committee must have regard to certain matters

- (5) In giving the requested advice to the Minister, the Emissions Reduction Assurance Committee must have regard to the following:
 - (a) the offsets integrity standards;
 - (b) any relevant matters specified in a direction in force under section 123B;
 - (c) any relevant advice given by the Regulator to the Committee.
- (6) Subsection (5) does not, by implication, limit the matters to which the Emissions Reduction Assurance Committee may have regard.

123B Additional matters for the Emissions Reduction Assurance Committee to take into account

The Minister may, by legislative instrument, direct the Emissions Reduction Assurance Committee to do any or all of the following:

- (b) the member advises the Committee that:
 - (i) if the Minister were to make a proposed methodology determination, the determination would not comply with the offsets integrity standard set out in paragraph 133(1)(c); or
 - (ii) if the Minister were to make a particular variation of a methodology determination, the varied determination would not comply with the offsets integrity standard set out in paragraph 133(1)(c);

then, in giving relevant advice to the Minister under subsection 123A(2), the Emissions Reduction Assurance Committee is to assume that the determination or varied determination, as the case may be, would not comply with that offsets integrity standard.

Note:

Paragraph 133(1)(c) is about ensuring that the method in a methodology determination relates to eligible carbon abatement.

123D Consultation by the Emissions Reduction Assurance Committee

- (1) The Emissions Reduction Assurance Committee must not advise the Minister to make or vary a methodology determination unless the Committee has first:
 - (a) published on the Department's website:
 - (i) a detailed outline of the proposed determination or variation, as the case may be; and
 - (ii) a notice inviting the public to make a submission to the Committee on the detailed outline by a specified time limit; and
 - (b) considered any submissions that were received within that time limit.
- (2) The time limit must be 28 days after the notice is published.
- (3) However, the time limit may be shorter than 28 days after the notice is published, so long as:
 - (a) the Emissions Reduction Assurance Committee considers that the time limit is appropriate in the circumstances; and

Publication of submissions

124A Modified meaning of *crediting period* for an emissions avoidance offsets project that has an extended accounting period

 - (a) the application of another methodology determination to the project, with effect from a particular time; or
 - (b) the application of the original determination as varied to the project, with effect from a particular time;

subsection (2) does not apply to the project during so much of the crediting period as occurs after that time.

128 Request to approve application of methodology determination to a project with effect from the start of a reporting period

- (1) During a reporting period for an eligible offsets project, the project proponent for the project may request the Regulator to approve the application of a specified methodology determination to the project with effect from the start of the reporting period.
- (2) A request must:
 - (a) be in writing; and
 - (b) be in a form approved, in writing, by the Regulator; and
 - (c) be accompanied by such information as is specified in the regulations or the legislative rules; and

- (d) be accompanied by such other documents (if any) as are specified in the regulations or the legislative rules; and

- (5) A fee specified under paragraph (2)(e) must not be such as to amount to taxation.

- (2) If the person breaches the requirement, the Regulator may, by written notice given to the person:

- (iv) measurable; and
- (v) capable of being verified;
- (c) a method specified in, or ascertained in accordance with, a methodology determination in accordance with paragraph 106(1)(c) should provide that carbon abatement used in ascertaining the carbon dioxide equivalent net abatement amount for a project must be eligible carbon abatement from the project;

150A Ownership of Australian carbon credit unit

170 Simplified outline

The following is a simplified outline of this Part:

 If a person is convicted of an offence relating to fraudulent conduct, and the issue of Australian carbon credit units is attributable to the commission of the offence, a court may order the person to relinquish a specified number of Australian carbon credit units.

171 Units issued as a result of fraudulent conduct—court may order relinquishment

 - (c) an appropriate court is satisfied that the issue of any or all of the units was directly or indirectly attributable to the commission of the offence.

184 Simplified outline

The following is a simplified outline of this Part:

• The Regulator may obtain information or documents.

185 Regulator may obtain information or documents

Scope

(1) This section applies to a person if the Regulator believes on reasonable grounds that the person has information or a document that is relevant to the operation of this Act or the associated provisions.

Requirement

- (2) The Regulator may, by written notice given to the person, require the person:
 - (a) to give to the Regulator, within the period and in the manner and form specified in the notice, any such information; or
 - (b) to produce to the Regulator, within the period and in the manner specified in the notice, any such documents; or
 - (c) to make copies of any such documents and to produce to the Regulator, within the period and in the manner specified in the notice, those copies.
- (3) A period specified under subsection (2) must not be shorter than 14 days after the notice is given.

Compliance

(4) A person must comply with a requirement under subsection (2) to the extent that the person is capable of doing so.

Ancillary contraventions

- (5) A person must not:

 - (b) arrange for the audit team leader to carry out an audit on one or more aspects of the person's compliance with this Act or the associated provisions; and

241 Applications for reconsideration of decisions made by delegates of the Regulator

Scope

(1) This section applies to a reviewable decision if the decision is made by a delegate of the Regulator.

Application

- (2) A person affected by a reviewable decision who is dissatisfied with the decision may apply to the Regulator for the Regulator to reconsider the decision.
- (3) The application must:
 - (a) be in a form approved in writing by the Regulator; and
 - (b) set out the reasons for the application; and
 - (c) be accompanied by the fee (if any) specified in the regulations or the legislative rules.
- (4) The application must be made within:
 - (a) 28 days after the applicant is informed of the decision; or
 - (b) if, either before or after the end of that period of 28 days, the Regulator extends the period within which the application may be made—the extended period.
- (5) An approved form of an application may provide for verification by statutory declaration of statements in applications.
- (6) A fee specified under paragraph (3)(c) must not be such as to amount to taxation.

242 Reconsideration by the Regulator

- (1) Upon receiving such an application, the Regulator must:
 - (a) reconsider the decision; and
 - (b) affirm, vary or revoke the decision.
- (2) The Regulator's decision on reconsideration of a decision has effect as if it had been made under the provision under which the original decision was made.
- (3) The Regulator must give to the applicant a written notice stating the Regulator's decision on the reconsideration.

The committee known immediately before the commencement of this section as the Domestic Offsets Integrity Committee is continued in existence as the Emissions Reduction Assurance Committee.

255 Functions of the Emissions Reduction Assurance Committee

The Emissions Reduction Assurance Committee has the following functions:

 - (ii) are referred to the Committee by the Minister;
- (c) to advise the Secretary about matters that:
 - (i) relate to offsets projects; and

- (d) to monitor the compliance of methodology determinations with the offsets integrity standards;
- (e) to undertake periodic reviews of methodology determinations;

255A Crediting period extension reviews

- (1) For the purposes of this Act, a *crediting period extension review* means a review of whether a methodology determination should be varied so as to extend the crediting periods for the eligible offsets projects covered by the determination.
- (2) In performing the function conferred by paragraph 255(ha), the Emissions Reduction Assurance Committee must have regard to whether the relevant eligible offsets projects would still comply with the offsets integrity standard set out in paragraph 133(1)(a).
- (3) In performing the function conferred by paragraph 255(ha), the Emissions Reduction Assurance Committee must conduct such public consultation as it considers appropriate.

256 Membership of the Emissions Reduction Assurance Committee

The Emissions Reduction Assurance Committee consists of the following members:

- (a) a Chair;
- (b) at least 4, and not more than 8, other members.

257 Appointment of Emissions Reduction Assurance Committee members

(1) Each Emissions Reduction Assurance Committee member is to be appointed by the Minister by written instrument.

Note: An Emissions Reduction Assurance Committee member is eligible for reappointment: see the *Acts Interpretation Act 1901*.

- (2) A person is not eligible for appointment as an Emissions Reduction Assurance Committee member unless the Minister is satisfied that the person has:
 - (a) substantial experience or knowledge; and
 - (b) significant standing;

in at least one field of expertise that is relevant to the functions of the Emissions Reduction Assurance Committee.

- (3) The Minister must ensure that the Chair of the Emissions Reduction Assurance Committee is not a person covered by subsection (4).
- (4) This subsection applies to the following persons:
 - (a) an employee of the Commonwealth;
 - (b) an employee of an authority of the Commonwealth;
 - (c) a person who holds a full-time office under a law of the Commonwealth.

- (2) A resolution is taken to have been passed at a meeting of the Emissions Reduction Assurance Committee if:
 - (a) without meeting, a majority of Emissions Reduction Assurance Committee members indicate agreement with the resolution in accordance with the method determined by the Emissions Reduction Assurance Committee under subsection (3); and
 - (b) all Emissions Reduction Assurance Committee members were informed of the proposed resolution, or reasonable efforts had been made to inform all Emissions Reduction Assurance Committee members of the proposed resolution.

261 Disclosure of interests to the Minister

An Emissions Reduction Assurance Committee member must give written notice to the Minister of all interests, pecuniary or otherwise, that the member has or acquires and that conflict or could conflict with the proper performance of the member's functions.

262 Disclosure of interests to Emissions Reduction Assurance Committee

- (1) An Emissions Reduction Assurance Committee member who has an interest, pecuniary or otherwise, in a matter being considered or about to be considered by the Emissions Reduction Assurance Committee must disclose the nature of the interest to a meeting of the Emissions Reduction Assurance Committee.

- (5) For the purposes of making a determination under subsection (4), the Emissions Reduction Assurance Committee member:
 - (a) must not be present during any deliberation of the Emissions Reduction Assurance Committee for the purpose of making the determination; and
 - (b) must not take part in making the determination.
- (6) A determination under subsection (4) must be recorded in the minutes of the meeting of the Emissions Reduction Assurance Committee.

263 Outside employment

An Emissions Reduction Assurance Committee member must not engage in any paid employment that conflicts or may conflict with the proper performance of his or her duties.

264 Remuneration and allowances

- (1) An Emissions Reduction Assurance Committee member is to be paid the remuneration that is determined by the Remuneration Tribunal. If no determination of that remuneration by the Tribunal is in operation, the member is to be paid the remuneration that is prescribed.
- (2) An Emissions Reduction Assurance Committee member is to be paid the allowances that are prescribed.
- (3) This section has effect subject to the *Remuneration Tribunal Act* 1973.

265 Leave of absence

(1) The Minister may grant leave of absence to the Chair of the Emissions Reduction Assurance Committee on the terms and conditions that the Minister determines.

266 Resignation

- (2) The resignation takes effect on the day it is received by the Minister or, if a later day is specified in the resignation, on that later day.

Part 27—Secrecy

270 Secrecy

- (1) A person commits an offence if:
 - (a) the person is, or has been, an entrusted public official; and
 - (b) the person has obtained protected information in his or her capacity as an entrusted public official; and
 - (c) the person:
 - (i) discloses the information to another person; or
 - (ii) uses the information.

Penalty: Imprisonment for 2 years or 120 penalty units, or both.

Exceptions

- (2) Each of the following is an exception to the prohibition in subsection (1):
 - (a) the disclosure or use is authorised by a provision of this Part;
 - (b) the disclosure or use is in compliance with a requirement under:
 - (i) a law of the Commonwealth; or
 - (ii) a prescribed law of a State or a Territory.

Note: A defendant bears an evidential burden in relation to a matter in subsection (2) (see subsection 13.3(3) of the *Criminal Code*).

- (3) Except where it is necessary to do so for the purposes of giving effect to this Act or a legislative instrument under this Act, an entrusted public official is not to be required:
 - (a) to produce to a court or tribunal a document containing protected information; or
 - (b) to disclose protected information to a court or tribunal.

275 Disclosure to a Royal Commission

- (1) An entrusted public official may disclose protected information to a Royal Commission.
- (2) The Regulator may, by writing, impose conditions to be complied with in relation to protected audit information disclosed under subsection (1) by:
 - (f) an audit team leader; or
 - (g) a person assisting an audit team leader.
- (3) The Chair of the Emissions Reduction Assurance Committee may, by writing, impose conditions to be complied with in relation to protected ERAC information disclosed under subsection (1) by:
 - (a) the Chair; or
 - (b) an Emissions Reduction Assurance Committee member; or
 - (c) a person assisting the Emissions Reduction Assurance Committee under section 269.
- (4) An instrument under subsection (2) or (3) is not a legislative instrument.

276 Disclosure to certain persons and bodies

- (10) Subsection (9) does not prevent the Climate Change Authority from taking other matters into account in formulating a recommendation.
- (11) If a report of a review under subsection (1) sets out one or more recommendations to the Commonwealth Government, the report must set out the Climate Change Authority's reasons for those recommendations.

Government response to recommendations

- (12) If a report of a review under subsection (1) sets out one or more recommendations to the Commonwealth Government:
 - (a) as soon as practicable after receiving the report, the Minister must cause to be prepared a statement setting out the Commonwealth Government's response to each of the recommendations; and
 - (b) within 6 months after receiving the report, the Minister must cause copies of the statement to be tabled in each House of the Parliament.
- (13) The Commonwealth Government's response to the recommendations may have regard to the views of the following:
 - (a) the Climate Change Authority;
 - (b) the Clean Energy Regulator;
 - (c) such other persons as the Minister considers relevant.

307 Regulations

The Governor-General may make regulations prescribing matters:

- (a) required or permitted by this Act to be prescribed; or
- (b) necessary or convenient to be prescribed for carrying out or giving effect to this Act.

308 Legislative rules

The Minister may, by legislative instrument, make rules (*legislative rules*) prescribing matters:
